Pesticide labels have been provided along with this contract. Additional copies of pesticide labels are available upon request. Note: Any “post application” steps required by the label will be provided at the time of the application.

I select the specific date option instead of the planned approximate application(s) date(s) listed in the “Planned Application Dates” table above. I also understand that a new contract will be provided to me with the specific date(s) of applications.

This contract may be amended by an agreement to provide additional weed, insect or disease control services signed by Lawn Doctor and this purchaser. In the event such amendment(s), all notifications, disclosures and waivers herein will be applicable to and constitute a part of the amendment(s).
